SHH: Update on the Planning Inspectorate's January Hearings

The Planning Inspectorate's Examination period progressed with meetings at the beginning of the year (9th to 11th January) at which Save Honey Hill (SHH) was represented with good effect, bolstered on the last



day by our legal counsel. The live streams and transcripts are now available to watch on YouTube. Links are on the Save Honey Hill website.

Day one dealt with Compulsory Acquisition Orders (CA). As a group, Save Honey Hill is not affected by CA but nonetheless we were able to raise some very important questions as to why CA was needed as there is no compelling case to relocate the WWTP.

At the Issue Specific Hearing (Environmental Statement) on day two, the Inspectors concentrated in great detail on Traffic and Transport both for construction and operational traffic and the impact on Junction 34 and the associated roads, and on Waterbeach in relation to the Waterbeach pipeline. Yet again, there were discrepancies and omissions in the Applicant's documents which have to be corrected or questions answered by the next deadline (D4) on 22 January. This subsequently means more work for Save Honey Hill reading the answers and commenting where necessary. The Inspector emphasised that Anglian Water (Anglian Water) and National Highways (NH), and in some instances, Cambridgeshire County Council Highways, must talk to each other.

On the third day, which lasted a marathon 10 hours, we raised important issues around Ecology, Water Resources, including Flood Risk, Historic Environment, Landscape, visual and design, and Green Belt. Although the latter was somewhat hurried, our barrister was able to refute some of the points made by the council officer, although not accepted by the Applicant's KC. The Planning Inspectors tasked with scrutinising Anglian Water's DCO application documents, are showing themselves to be canny, thorough and diligent. The points raised reflect points raised by Save Honey Hill in both its Relevant and Written Representations and so we continue to feel listened to, included in the process and

extremely encouraged that Anglian Water is being and will continue to be called to account at every opportunity.

Within our communities, we have been blessed with a small number of professionals with the relevant experience to deal with a campaign of this kind and magnitude. It is largely due to the quality and strength of their knowledge and strategic skills that we are being accepted as a very credible participant in the process by the Examining Authority. For the past three years, they have all given freely a considerable amount of their time to working tirelessly to get to this point and we are truly grateful and indebted to them. We believe, it is due in large part to the level of expertise within our ranks in bringing many of the issues within this application to the Examining Authority's attention, that Anglian Water's representatives were sent, subsequent to October's Preliminary Hearings, a 132-page document of further questions.

We are seeing evidence that Save Honey Hill is having an impact on the course these plans are taking and are able to say our hard work is helping the Examining Authority have all the information it needs to make the best- informed decision possible and ensure that our communities have the very best possible outcome.

The support from all of you in providing the funds necessary to seek legal counsel thus far has been crucial. Without the highest-level legal expertise required to fight such a major infrastructure project, our efforts may have been fruitless. Legal counsel is not cheap, yet our legal team has worked with us and supported us in such a way we can say we have had excellent value for money.

We have been on this campaign journey now for over three years and regardless of whether new funding is forthcoming, we are committed to fighting to the end.

Horningsea Greenway and more works; update

The Parish Council had a call with the GCP on the 17th January for an update on the various works happening in the village.

Timings

As a guide only as the timings are moving....

The footpath resurfacing works from the village gateway to the A14 are due to take place from the 9th of February for about 3 weeks.

The build-out works and other remaining Horningsea works are due to commence on the 1st of March.

We will do our best to keep you updated with any changes to this.

Lamposts

The GCP is going to look at how they can rationalise the number of lampposts that have been fitted.

The GCP is also going to look at the possibility of extending the 20mph zone into Dock Lane, St John's Land and Priory Road, although no promises have been made on this.

Build out location

I believe the GCP has amended the location of the build-outs to rectify the concerns raised. <u>If there are any outstanding concerns please let us know so we can pick this up with the GCP/ their contractor.</u>

Lighting

It has been confirmed that the proposed lighting between the village gateway and the A14 will be a like-for-like replacement of the lighting currently in situ.

Speed limit

GCP has currently removed the 40mph buffer zone to the South of the Village, this will be reinstated back to 40mph on Monday.

Bus stops

The GCP will additionally be installing line markings to the two bus stops this will be undertaken alongside the build-out construction.

Non-GCP update

Footpaths

Separately to the GCP works you would have seen a lot of white spray markings appearing over the pavements on the High Street and Clayhithe Road. This relates to pavement resurfacing works that Highways will be undertaking. The resurfacing works are due between 8th February - 8th March.

We are in communication with the Highways team to ensure the stretch of placement between Gayton Farm and Northgate Farm where we have lost at least a foot of pavement due to vegetation encroachment is cleared before the resurfacing.
